At the end of July, 230 participants were registered in spot market, 79 were enrolled in the Intraday Market, 557 companies were listed in the Trading registry of Centralized Market for Electricity Bilateral Contracts and 43 companies were listed as registered participants to the Centralized Market with double continuous negotiation for Electricity Bilateral Contracts (CM-OTC) and 2 participants were registered in the Electricity Market for Large Consumers (LCM).

Green Certificates Market had 707 registered participants at July 31, while 12 companies were listed as registered participants to the Trading Platform for Emission Certificates (TPEC).

At the end of July, 12 companies were listed as registered participants to the Centralized Market for Natural Gas.
