At the end of May, 281 participants were registered in spot market, 110 were enrolled in the Intraday Market, 309 companies were listed in the Trading registry of Centralized Market for Electricity Bilateral Contracts Extended Auction mechanism, 107 companies were listed in the Trading registry of Centralized Market for Electricity Bilateral Contracts Continuous Negotiation mechanism, one company was listed in the Trading registry of Centralized Market for Electricity Bilateral Contracts Fuel Processing mechanism, 69 companies were listed as registered participants to the Centralized Market with double continuous negotiation for Electricity Bilateral Contracts (CM-OTC), 26 participants were registered in Centralized Market for Universal Service and 2 participants were registered in the Electricity Market for Large Consumers (LCM).

Green Certificates Market had 781 registered participants at May 31, while 12 companies were listed as registered participants to the Trading Platform for Emission Certificates (TPEC).

At the end of May, 16 companies were listed as registered participants to the Centralized Market for Natural Gas.
