

**AMENDMENT AGREEMENT dated 18.02.2021**

**BETWEEN**

- (1) MET Romania Energy S.A. a company organised and existing under the laws of **Romania** whose registered office is at 93-95 Emanoil Porumbaru at. 1<sup>st</sup> floor, 1<sup>st</sup>. District 011424, Bucharest, Romania (“**METRO**”), and
- (2) MET Energy Trading Bulgaria EAD (“**METBG**”) a company organised and existing under the laws of Bulgaria whose registered office is at 109, Bulgaria Blvd, Vertigo Business Tower, Office 23, 1404, Sofia, Bulgaria (“**METBG**”);

**METRO** and **METBG** are each referred to individually as a “**Party**” and collectively as the “**Parties**”.

**WHEREAS** **METRO** and **METBG** have entered into an individual Contract under EFET reference dated **18.02.2021** (the “**Agreement**”).

**WHEREAS** **MET RO** and **MET BG** desire to amend the Agreement as pursuant to the terms of this Amendment Agreement.

**NOW THEREFORE, IN CONSIDERATION** of the mutual agreements herein contained, the Parties agree as follows:

**A. Amendments to the Individual Contract**

This Amendment Agreement shall be governed by and construed in accordance with the governing law of the Agreement, and may be executed in counterparts, each of which taken together shall constitute one and the same instrument.
