All the provisions of the Contract, which are not amended i.e., not inconsistent with the provisions of this Addendum 3, remain in full force and effect. This Addendum 3 is an integral part of the Contract.

Provisions of this Addendum 3 come into force and shall be effective as of date of its signing and shall apply for deliveries from 1<sup>st</sup> of January 2024 onwards.
