EFT AG and EFT POWER hereinafter jointly referred to as the “Parties”

RECITALS

- A. **WHEREAS** the Parties signed the Contract for Sale of Electricity No. IC EFT POWER selling to EFT CH 01.07.2024-31.12.2024 RO 2180/2024 (hereinafter referred as "AGREEMENT"
- B. **WHEREAS** Parties wish to change the agreed delivery characteristics

Therefore, the Parties agree as follows:

Article 1

Words and expressions used in this Annex 1 have the same meaning as in the Agreement.

Article 2

Parties wish to amend the Agreement by redefining the Delivery characteristics envisaged in Article 3 of the Agreement, and consequentially Articles 4 and 5, so they all now read as follows:
