




Figure 1: Daily DAM price development (base, peak and off-peak)




Figure 4: Daily evolution of available ATC for implicit auctions and of cross border flows coupling results on Hungary border - SDAC coupling




Figure 5: Daily evolution of available ATC for implicit auctions and of cross border flows coupling results on Bulgaria border - SDAC coupling




Figure 6: Monthly development of traded volumes on DAM and centralised market for bilateral contracts with delivery in the analysed period




Figure 7: Monthly development of average price on DAM and on centralised market for bilateral contracts
